Reporting to the Director, Programs, the incumbent in this role will be responsible for providing wellness solutions for Variety Village members and the general public through professional massage therapy. A thorough knowledge of numerous massage modalities will be used to identify and apply specific therapies to meet the clients' individual needs.

### **Responsibilities include, but are not limited to:**

- Providing professional massage and body treatments on site at the Variety Village facility;
- Adhering to accepted certification practices and protocols as required by the College of Massage Therapists of Ontario;
- Ensuring clients feel welcomed and are treated with respect;
- Guiding clients through service offerings and helping them to choose the types of massages that would be most beneficial to their individual situation;
- Promoting the benefits of massage therapy as specific to each client;
- Maintaining required client notes including detailed history, injuries and/ or medical conditions;
- Designing sessions to meet the client's specific complaints or problem areas;
- Listening to clients during massage and adjusting techniques to meet their needs;
- Suggesting massage schedules for recurring sessions as required;
- Ensuring treatment room is maintained in a clean and orderly fashion;
- Treating client information with the highest regard for confidentiality and in adherence with PIPEDA and Variety Village policies;
